- 2. Innovation Zone and School Renewal Discussion
- Bailey gave the board an overview of the working agreements and reviewed the plan

- a. The zone plan focuses on the Work of LLN as an organization.
- b. No waivers being sought; more focused on shared Zone structures and how we support the schools within the LLN.
- c. The zone has been trending positively—when Bailey joined the LLN, we had schools that were red or yellow,
- d. LLN staff has supported schools in their work of day to day school leadership
- e. All schools received a rating of GREEN on the state SPF. And while there is still work to be done, this zone and the data show that we are improving outcomes for students and families as agreed upon metrics shared with DPS.
- f. LLN is aligned to DPS articulated best practice for governing.
- g. LLN is grounded in our common interests as schools and our grounded common theory of action.
