In partnership with Denver Public Schools, the LLN ensures that schools have the operational and financial autonomy and flexibility they need in order to execute their innovation plans with fidelity and customize their educational model in order to best serve students. In addition, the LLN provides executive coaching, school reviews, and professional development opportunities for all member schools.
